

## ORDINANCE NO. \_\_\_\_\_

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF HEARNE, TEXAS, AMENDING ORDINANCE NUMBER **09-05-2017** WHICH ORDINANCE ADOPTED THE ANNUAL BUDGET FOR THE CITY OF HEARNE, TEXAS FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2017 AND ENDING SEPTEMBER 30, 2018; PROVIDING FOR COSTS OF BUILDING MAINTENANCE OF THE BUDGET OF THE ECONOMIC DEVELOPMENT CORPORATION TYPE B; PROVIDING FOR REPEAL OF ORDINANCES IN CONFLICT HEREWITH;

WHEREAS, the City Council adopted the annual budget for the City of Hearne, Texas on September 05, 2017; and

WHEREAS, the City Council of the City of Hearne, Texas, desires to amend the approved Budget Ordinance; and

WHEREAS, funding for the city's EDC expenditures of Incentives/Contingencies costs were included in such budget and it is found that these funds will be used in Building Maintenance costs; and

WHEREAS, the budget Amendment will increase EDC's Type B expenditures by \$200,000, while reducing Incentives/Contingencies expenditures budget by same amount; and

WHEREAS, this amendment to EDC's Type B budget does not increase the expenditures budget for the current fiscal year; and

WHEREAS, this amendment represents an increase in one line item of the budget and a decrease in another; and

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF HEARNE, TEXAS AS FOLLOWS:

SECTION 1. Enacted.

The expenditures of the EDC Type B Annual Budget for the City of Hearne, Texas for the Fiscal Year beginning October 1, 2017 and ending September 30, 2018 are hereby increased by an amount not to exceed \$200,000 in Building Maintenance.

SECTION 2. Enacted.

The expenditures of the EDC Type B Annual Budget for the City of Hearne, Texas for the Fiscal Year beginning October 1, 2017 and ending September 30, 2018 are hereby decreased by \$200,000 in Incentives/Contingencies.

SECTION 3: Continuing effect.

The remaining portions of Ordinance Number **09-05-2017** shall remain in full force and effect.

SECTION 4: Repeal

All ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of the conflict.

SECTION 5. Publication.

The City Secretary is hereby authorized and directed to cause the publication of this ordinance in accordance with law.

SECTION 6. Effective Date.

This ordinance shall be in force and effect from and after its publication as required by law.

SECTION 7. The passage of this ordinance constitutes an emergency and an imperative public necessity that the Charter Rule requiring that City ordinances be read at two (2) separate meetings of the City Council be suspended, and said rule is hereby suspended, and this ordinance shall take effect immediately upon its passage.

**PASSED AND APPROVED** on a regular meeting of the City Council on the **21st** day of **November, 2017**, with all members present voting "aye" for the passage of same.
